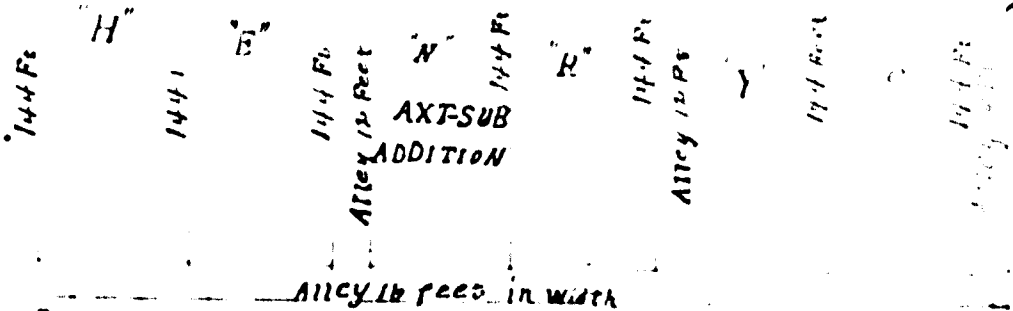


Sub-division of part of Lot No 4 in John Clark's addition by 1877 (E.S.)

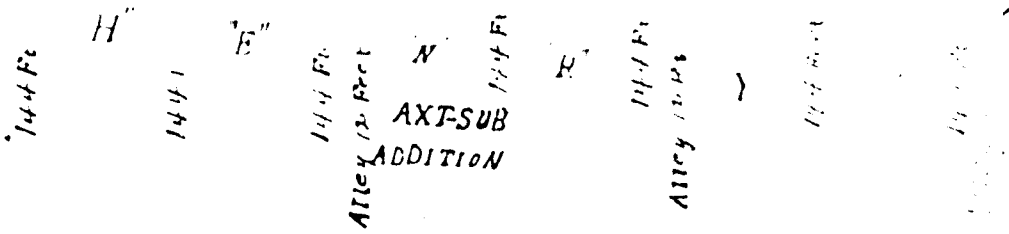

That Henry C. Apt. of Johnson County and State of Indiana hereby makes a sub-division of a part of lot number four in John Clarke's addition to the city of Franklin, Indiana, to be known as the Henry C. Apt. sub-division of a part of lot number four in John Clarke's addition to the City of Franklin, Indiana, and described as follows, to-wit:

Beginning at the North west corner of said lot number four in John Clarke's addition to the City of Franklin, Indiana; thence South on the West line of said lot three hundred thirty (330) feet more or less to the South west corner of said lot; thence East on the North line of said lot one hundred fifty four (154) feet; thence North and parallel with the said West line of said lot three hundred thirty (330) feet more or less to the North line of said lot; thence West on said North line one hundred fifty four (154) feet to the North west corner of said lot and to said point of beginning.

The lots and alleys and their dimensions being shown by the annexed plat. In witness whereof the said Henry C. Apt. has hereunto set his hand and seal this 10th day of October, A.D. 1900.
