entire South side of Lot 281 in 194, both inclusive;

Subject to all rights, easements, covenants, restrictions, conditions, and stipulations contained in the original Deed of Trust, and all other documents, agreements, contracts, and instruments, now or hereafter existing, relating to the property herein described, and all subsequent alterations, for the purpose of public property.


