- (i) There has been or will be created, under the laws of the State of Indiana, a not-for-profit corporation to be known as the "Castle Cove Owners' Assn., Inc.", which is referred to as the "Association". Every Owner of a residential Lot in the Development shall be a member of the Association. Each Covner of a residential Lot within the Development shall be subject to all the requirements and limitations imposed in these Restrictions on other Owners of residential Lots within the Development and on members of the Association, including those provisions with respect to the payment of an annual charge.
- (ii) In addition to the foregoing, the Board of Directors of the Association may establish associate memberships in the Association for persons who are not otherwise entitled to the benefits of membership by virtue of being Owners of residential Lots within the Development. Associate members shall have none of the rights of members to vote at meetings of the Association. The Board of Directors of the Association may establish fees or charges for such associate memberships and rules and regulations concerning such associate memberships which may be different from those applicable to members generally.

B. Purposes of the Association.

- (i) The general purpose of the Association is to provide a means whereby those areas within the povelopment designated as Common Property on the plats ereof, and such other recreational facilities within the Development as may be conveyed to the Association or established by it, may be operated maintained, repaired and replaced.
- (ii) An additional purpose of the Association is to provide a means for the promulgation and enforcement of

regulations accessary to govern the use and enjoyment of such Common Properties or other amenities and recreational facilities within the Development as may be conveyed to the Association.

- C. Power of Association to Levy and Collect Charges and Impose Lieus.
- (i) The Association shall have all the powers set forth in its Articles of Incorporation, together with all other powers that belong to it by law, including the power to levy a uniform annual charge or assessment against the Lots within the Development. Such charge shall be \$125.00 per lot year for each platted residential Lot in the Development until January 1, 1985, or until 164 Lots are sold, whichever occurs later; provided, however, assessments on platted Lots shall be 50% of the foregoing assessment until such time as a residence is built and conveyed to an Owner as defined herein. Further, the Board of Directors of the Association may increase the assessment not to exceed 10% per annum, without the consent of the Owners, as hereinafter set forth in paragraph D(iv).
- (ii) Membership and Voting Rights. Every Owner of a Lot shall be a member of the Association. For purposes of determining classes of membership, a Class A Member shall be the Owner of any conveyed Lot containing a Dwelling, and a Class B Member shall be the Owner of any undeveloped, platted Lot, and each reference to a Lot in Section 2(a), 2(b) or 2(c) of this Paragraph C shall be deemed to be a conveyed Lot containing a Dwelling or an unconveyed, platted or unplatted, Lot, respectively
- of Membership:
- (a) Class A. Every person, group of persons or entity, other than the Developer, who is a record owner of a fee interest in any improved Lot which is or becomes subject, by covenants of record, to assessment by the Association, provided thowever, that any such person, group of persons or entity who holds such interest solely as security for the performance of a obligation shall not be a Member. A Class A Membership shall be appurtenant to and may not be separated from ownership of any Lot which is subject to assessment? Class A Members shall be entitled to one (1) vote for each lot in which they hold the interest required for membership. In the event that more than one person; group of persons or entity is the record owner of a fee interest in any Lot, then the vote for the membership appurtenant to such Lot shall be exercised as they among themselves determine but in no event shall more than one (1) vote be cast with respect to any Lot. In the event agree on is not reached, the vote attributable to such Lot shall not be cast.

(b) Class B. The Class B Member shall be the Developer and shall be entitled to three (1) votes for each, votes for each platted lot owned. For purposes of determining voting rights and duties, it shall be assumed there is a total of two hundred seventeen (217) platted and unplatted Lots within the Properties and Developer shall have the automatic right to plat and record Sections, not to contain in excess of two hundred seventeen (217) Dwellings without the consent or approval of the Association or any other person, firm or corporation. The Class B Membership shall cease and be converted to a Class A Membership on the happening of cither of the following events, whichever occurs later: Whenever the total votes outstanding of Class A Membership equals one hundred sixty four (164), or on January 1, 1986, in the event all the Lots have not been conveyed to the Owners or the Class B Memberships have not been surrendered by the the holders thereof for cancellation on the books of the Association. Class B Memberships existing, if any, at time of cancellation, shall automatically become Class A Memberships. As long as there is a Class B membership, the following actions will require prior approval of the Federal Housing Administration of the Veterans Administration: annexation of additional properties; dedication of common area; and amendments to the Declaration of Covenants, Conditions and Restrictions.

D. Covenant for Maintenance Assessments Class A and Class B Members.

Each Owner of any Lot by acceptance of a deed therefor, whether or not it shall be so expressed in such deed, is deemed to covenant and agree to pay to the Association: (1) annual assessments or charges, and (2) special assessments for capital improvements; such assessments to be established and collected as hereinafter provided.

All sums assessed by the Association shall be established by using generally accepted accounting principles applied on a consistent blass and shall include the establishment and maintenance of a replacement reserve fund for capital expenditures and replacement and repair of the Common Areas and facilities, which funds shall be used for those purposes and not for usual and funds shall be used for those purposes and not for usual and fordinary repair expenses of the Common Areas and facilities. This fund for capital expenditures shall be maintained in a separate fund for capital expenditures shall be maintained in a separate interest bearing account with a bank or savings and loan association authorized to conduct business in the county in which the Association is established.

Indemuch as the annual budget for the Association will have a deficit until all Lots are platted, assessments during the build-out period shall be paid to Developer and Déveloper shall be financially responsible to pay all Association expenses.

In addition, as each assessment is paid to beveloper, that portion of each assessment allocable to the replacement reserve fund in accordance with each annual budget shall be a posited and maintained in a separate interest bearing account as defined above. The difference between assessments paid by owners and 217 lots shall be funded by Developer in said replacement reserve fund until such time as Class B memberships in the Association expire as hereinbefore set forth. Said deficit in operating expense and contributions to replacement reserve fund to be paid by Developer shall constitute a lien upon the Property described in Exhibit A secondary only to the mortgage securing the land development loan and the lien of a first mortgage upon an improved Lot. Such lien shall be collectible in the same manner as regular annual assessments as hereinafter provided.

Further, at the time Class B memberships in the Association expire, Developer shall fund the Association with a sum equal to twenty-five per cent of the budgeted ensuing twelve months' usual and ordinary expenses to create a fund sufficient for the Association to meet its current obligations as they accrue until its current collection of assessments is sufficient to meet its current expense.

The annual and special assessments, together with interest, a late charge of 1 1/23 per month commencing 30 days after due date, costs and reasonable atterney's fees, shall be a charge on the Lot and shall be a continuing lien upon the property against which each such assessment is made. Each such assessment, together with interest, costs, and reasonable attorney's fees, shall also be the personal obligation of the person who was the Owner of such property at the time when the assessment fell due. The personal obligation for delinquent assessments shall not pass to his successors in title unless expressly assumed by them, but such delinquent accounts shall remain a lien upon the Lot subject to foreclosure.

- (1) Purpose of Assessments. The assessments levied by the Association on a lot shall be used exclusively to promote the recreation, health, safety and wellare of the residents in the Properties and for the improvement and maintenance of the Common Areas and mail not inure to the benefit of Developer or third parties, or in any manner jeopardize the not-for-profit corporate status of the Association pursuant to the U.S. Internal Revenue Code or the laws of the State of Indiana.
- Due Dates. The annual assessments provided for herin shall communice as to all Lots on the first day of the month following the initial conveyance of the Common Area to the Association. The first annual assessment shall be adjusted according to the number of months remaining in the calendar year and thereafter until the Board of Directors fixes the permanent annual assessment date. The Board of Directors shall fix the amount of the annual assessment against each Lot at least thirty (30) days in advance of each annual assessment be sent by every Owner subject thereto. The Association shall upon demand, and for a reasonable charge, furnish a certificate signed by an afficer of the Association setting forth whether the assessments on a specified Lot have been paid. A properly executed certificate of the Association as to the status of assessment on a Lot is binding upon the Association on the date of its issuance.

(iii) Unitorm Rates of Assessment. Both annual and special assessments shall be fixed at a uniform rate for all fots. Annual assessments may be paid on a monthly, quarterly or semi-annual basis, but, if paid on other than an annual basis, default in the payment of any one installment shall cause the entire unpaid assessment for the year in which the delinquency occurs to become immediately due and payable.

(iv) Maximum Annual Assessment, Until January 1, 1981, the maximum annual assessment shall be \$ 125.00. For the ensuing four (4) calendar years, because of uncertainties in usual and ordinary Common Area expenses due to the Indiana real property reassessment, rising costs of energy and other unforesceable operating expenses, the Board of Directors of the Association may increase the assessment by a sum not to exceed 10% per annum without vote of the Membership. However, any such increases shall be documented by normal accounting procedures and distributed to the Membership to demonstrate that such increases are attributable to increases in operating expenses and no portion of such increases shall inure to the benefit of the Developer and the moneys received shall be entirely expended on Association expense.

(a) From and after January 1, 1985, the maximum annual assessment per Lot may be increased each year without a vote of the Membership, as provided below on the basis of "The Revised Consumer Price Index - Cities [1957-1959=100]" (hereinafter called "CPI"), published by the Bureau of Labor Statistics of the United States Department of Labor. The CPI Number indicated in the column for the City of Indianapolis, entitled "All Items", for the month of November of the year preceding the year in which the conveyance of the first Lot to an Owner occurs, shall be the "Base CPI Number"; and the corresponding CPI Number for the month of November of the year in which the conveyance of the first Lot to an Owner shall be "Current CPI Number". The Current CPI Number shall be divided by the Base CPI Number. From the quotient thereof, there shall be subtracted an Integer of One (1) ; and the resulting positive number shall be deemed to be the maximum percentage that the annual assessment per Lot may be increased above the maximum assessment for the previous year without a vote of the Membership Bach succeeding year thereafter, the maximum percentage increase of assessment over the previous year without a vote of the Membership shall be determined in a like manner, provided, however, the Current CPI Number for each previous year shall be deemed the Base QI Number for cach succeeding year in the computation of the maximum percentage in rease. In the event the actual percentage increase of assessment in any year by the Association is less than the maximum allowed without a vote of the Membership, the difference, between the actual percentage. increase and the maximum percentage increase, may be added to the percentage increase for the following year in determining the maximum percentage increase of assessment allowed without a vote of the Membership for such year.

- (b) From and after January L of the year immediately following the conveyance of the first Lot to an Owner until "amuary L 1986, the maximum annual assessment per Lot may be increased above the maximum percentage set forth above only by a vote of two-thirds (2/3) of the Class A Members who are voting in person or by proxy, at a meeting duly called for this purpose.
- (c) The Board of Directors may fix the annual assessment per lot at an amount not in excess of the maximum.
- (v) Special Assessments for Capital Improvements. In addition to the annual assessments authorized above, the Association may lovy, in any assessment year, a special assessment applicable to that year only for the purpose of defraying, in whole or in part, the cost of any construction, reconstruction, repair or replacement of a capital improvement upon the Common Area, including fixtures and personal property related thereto, provided that any such assessment shall have the assent of two-thirds (2/3) of the votes of Class A Members.
- Under Paragraphs (iv) and (v) Above. Written notice of any meeting called for the purpose of taking any action authorized under paragraphs (iv) and (v) above shall be sent to all Class and Class B Members not less than thirty (30) days nor more than sixty (60) days in advance of the meeting. At the first such meeting called, the presence of Class A and Class B Members or of proxies entitled to cast sixty percent (60%) of all the votes of the Class A and B Membership shall constitute a quorum. If the required quorum is not present, another meeting may be called subject to the same notice requirement, and the required quorum at the subsequent meeting shall be one-half (1/2) of the required quorum at the preceding meeting. No such subsequent meeting shall be held more than sixty (60) days following the preceding meeting shall be held more than sixty (60) days following the

(viii) Subordination of the Lien to Mortgages. The Jien of the assessments provided for in this paragraph D shall be supordinate to the lien of any first mortgage. Sale or transfer of any bot shall not affect the assessment lien. However, the sale or transfer of any Lot pursuant to mortgage foreclosure or any proceeding in lieu thereof, shall extinguish the lien of such assessments as to payments which became due prior to such sale or transfer. No sale or transfer shall relieve such Lot from liability for any assessments thereafter becoming due or from the lien thereof.

(ix) <u>Euspension of Privileges of Membership.</u>
Notwithstanding any other provision contained herein, the Board of Directors of the Association shall have the right to suspend the voting rights, if any, and the right to use the facilities of the Association of any member or associate member (i) for any period during which any of the Association's charges owed by the member or associate member remains unpaid; (ii) during the period of any comminuing violation of the restrictive covenants for the Development, after the existence of the violation shall have been declared by the Board of Directors of the Association; and (iii) during the period of any violation of the Articles of Incorporation, by-Laws or regulations of the Association.

- 10. RIGHTS OF MORTGAGEE. Unless at least seventy-five per cent of the first mortgagees (based upon one vote for each first mortgage owned) or the Class A members have given their prior written approval, the Association shall not:
- (i) By act or omission, seek to abandon, partition, subdivide, encumber, sell or transfer the Properties, Common Area or improvements located thereon which are comed directly or indirectly by the Association for the benefit of the Lots. The granting of easements for public utilities or for other public purposes consistent with the intended use of the Properties by the Association shall not be deemed a transfer within the meaning of this clause.
- (ii) Change the method of determining the obligations, as essments dues or other charges which may be levied against a Lot of Owner/
- (iii) By act or omission, change, waive or abandon any scheme of regulation or enforcement thereof pertaining to the architectural design or exterior appearance of the Dwellings on Lots, the exterior maintenance of the Dwellings on Lots, the maintenance of party walls or common fences driveways or the upkeep of lawns and plantings in the Properties.
- (iv) Fail to maintain fire and extended coverage insurance on insurable Common Area on current replacement cost bas 3 in an amount not less than one hundred per cent of the insurable value (based on current replacement cost).
- (v) Use hazard insurance proceeds for losses to Common/Area for other than the legalr, replacement or reconstruction of such improvements

(e)) Mortgages, their successors or assign, shall have the right to examine the books and records of the Association.


(vii) Pirst mortgages of Dwellines on Lots may, jointly or singly, pay taxes or other charges which are in default and which may or have become a charge against any Common Area or Limited Common Area and may pay overdue premiums on bahard insurance policies, or secure new hazard insurance coverage on the lapse of a policy, for such Common Area and Limited Common Area, and first mortgagees making such payments shall be oved immediate reimbursement therefor from the Association. Entitlement to such reimbursement shall be reflected in an agreement in favor of all first mortgagees dul executed by the Association, and an original or certified copy of such agreement shall be possessed by the Seller as defined by Sellers' Juides for the Federal Home Loan Mortgage Corp.

(viii) No provision of the constituent documents shall give a Lot Owner or any other party priority over any rights of first mortgages of Dwellings within the Properties pursuant to their mortgages in the case of a distribution to Lot Owners of insurance proceeds or condemnation awards for losses to or a taking of Common Area or Limited Common Area.

11. REMEDIES.

- benefit these Restrictions inure, including the Developer, may proceed at law or in equity to prevent the occurrence or continuation on any violation of these Restrictions, but neither the Developer not the Association shall be liable for damages of any kind to any person for failing either to abide by, enforce or carry out any of these Restrictions.
- (ii) Delay or Failure to Enforce. No delay or failure on the part of any aggrieved party to invoke any available remedy with respect to a violation of any one or more of these Restrictions shall be held to be a waiver by that party for an estoppel of that party to assert) any right available to him upon the occurrence, recurrence or continuation of such violation or violations of these Restrictions.
- 12 EFFECT OF BECOMING AN OWNER. The Owners of any lot subject to these Restrictions, by acceptance of a deed conveying title to these Restrictions, by acceptance of a deed conveying title the letter, or the execution of a contract for the purchase thereof, thereto, or the execution of a contract for the purchase thereof, what here from the Developer of a subsequent owner of such to each and every accept such deed and execute such contract subject to each and every Restriction and agreement herein contained. By acceptance of such

The underlined titles preceding the various paragraphs and subparagraphs of the Restrictions are for convenience of reference only, and none of them shall be used as an aid to the construction of any provision of the Restrictions. Wherever and whenever applicable, the singular form of any word shall be taken to mean or apply to the plural, and the masculine form shall be taken to mean or apply to the feminine or the neuter.
- 14. FURATION AND AMENDMENT. The foregoing covenants and restrictions are to run with the land and shall be binding on all parties and all persons claiming under them until January 1, 2002, at which time said covenants and restrictions shall be automatically extended for successive periods of ten (10) years, unless changed in whole or in part by vote of those persons who are then the Owners of a majority of the numbered Lots in the Development. The declaration may be amended the first twenty (20) years by an instrument signed by not less than severity-five percent (75%) of the lot owners. Any amendment must be recorded.
- hereby declared to be independent of, and severable from, the rest of the Restrictions and of and from every other one of the Restrictions, and of and from every combination of the Restrictions. Therefore, if any of the Restrictions shall be held to be invalid or to be unenforceable, or to lack the quality of running with the land, that holding shall be without effect upon the validity, enforceability or trunning quality of any other one of the Restrictions.
