

Plat Book 6, page 35, of the records of the Recorder's Office, Johnson County, Indiana, shows the following:—

CEDAR HILLS - Third Section

A part of the west half of the southwest quarter of Section 14, Township 13 North, Range 3 East of the second principal meridian and more particularly described as follows:

Beginning at a point on the west line of said half-quarter section, 1041 feet south of the northwest corner thereof; thence-south on and along said west line 630.0 feet to a point; thence north 380 - 45° east 1321.4 feet to a point on the east line of said half-quarter section; thence north on and along said east line, 1678.6 feet to the northeast corner of said half-quarter section; thence west on and along the north line of said half-quarter section, 87.4 feet to a point; thence south parallel to the west line of said half-quarter section, 400.0 feet to a point; thence east parallel to the north line of said half-quarter section, 54.8 feet to a point; thence east 435.6 feet to a point; thence south parallel to the west line of said half-quarter section, 600.0 feet to a point, thence south 38 degrees - 44° west, 200.0 feet to a point; thence south 62 degrees - 44° west 141.0 feet to a point; thence south parallel to the west line of said half-quarter section, 358.0 feet to the north line of said half-quarter section 358.0 feet to the place of beginning; containing 24.2 acres more or less; subject to all legal highways or rights-of-way.

Also, a part of the southwest quarter of the northwest quarter of Section 14, Township 13 North, Range 3 East of the second principal meridian and more particularly described as follows:

Beginning at a point on the south line of said quarter-quarter section 1235.6 feet east of the southwest corner thereof; thence east on along said south line, 87.4 feet to the southeast corner thereof; thence north on and along the east line of said quarter-quarter section 35.6 feet to a point; thence west parallel to the south line of said quarter-quarter section, 87.4 feet to a point; thence south parallel to the east line of said quarter-quarter section, 35.6 feet to the point of beginning, containing 0.1 acres more or less, subject to all legal highways or rights-of-way.

Also, a part of the southeast quarter of the northwest quarter of Section 14, Township 13 North, Range 3 East of the Second Principal Meridian and more particularly described as follows:

Beginning at the southwest corner of said quarter-quarter section, thence east on and along the south line of said quarter-quarter section, 1327.7 feet to the southeast corner thereof; thence north on and along said east line, 110.0 feet to a point; thence south 39 degrees - 30° west 733.5 feet to a point; thence south parallel to the east line of said quarter-quarter section, 66.6 feet to a point; thence west parallel to the south line of said quarter-quarter section 592.2 feet to a point on the west line of said quarter-quarter section; thence south on and along said west line, 35.6 feet to the place of beginning containing 2.24 acres more or less; subject to all legal highways or rights-of-way.

Also, a part of the northeast corner of the southwest quarter of Section 14, Township 13 North, Range 3 East of the second principal meridian and more particularly described as follows:

Beginning at the northeast corner of said quarter-quarter section; thence south on and along the west line of said quarter-quarter section, 949.4 feet to a point; thence east parallel to the north line of said quarter-quarter section, 127.4 feet to a point; thence north 73 degrees - 50° east, 376.0 feet to a point; thence north 43 degrees - 59° east, 376.0 feet to a

point; thence north 30 degrees - 00' east, 560.0 feet to a point; thence south 76 degrees - 32' east, 306.2 feet to a point on the east line of said quarter-quarter section; thence north on and along said east line, 178.0 feet to the northeast corner thereof; thence west on and along the north line of said quarter-quarter section 1327.7 feet to the place of beginning, containing 16.6 acres more or less; subject to all legal highways or rights-of-way.

ROADS

Cedar Hills Third Section; Honey Creek Boulevard and Hillside Drive shall each have a fifty (50) foot easement with a twenty-four (24) foot improved road bed constructed with aggregate to the thickness of six (6) inches with a two (2) inch bituminous coated aggregate top coating.

DEED OF DEDICATION

"We, the undersigned Doris H. Orme, Hubert S. Orme, owners of the real estate shown and described herein, do hereby certify that we have laid off, platted and subdivided, and do hereby lay off, plat and subdivide, said real estate in accordance with the within plat.

This subdivision shall be known and designated as CEDAR HILLS, Third section, JOHNSON COUNTY. All streets and alleys shown and not heretofore dedicated, are hereby dedicated to the public.

Front and side yard building setback lines are hereby established as shown on this plat, between which lines and the property lines of the streets, there shall be erected or maintained no buildings or structure.

There are strips of ground, 20 foot and 10 foot widths as shown on this plat and marked "Easement", reserved for the use of public utilities for the installation of water and sewer mains, poles, ducts, lines and wires, subject at all times to the proper authorities and easements herein reserved. No permanent or other structures are to be erected or maintained upon said strips of land, but owners of lots in this subdivision shall take their titles subject to the rights of the public utilities.

RESTRICTIVE COVENANTS

1. The land covered by this conveyance may not be sold except as a unit and only one single residence may be erected thereon, except by approval of the majority of the other residents of Cedar Hills.
2. The ground floor area of the main structure, exclusive of open porches and garages, shall be not less than 1,200 sq. ft. for a one story dwelling and not less than 900 sq. ft. for a dwelling of more than one story.
3. No dwelling shall be permitted on any tract unless it be built of at least 25% brick or stone veneer construction.
4. No residence shall be occupied prior to completion and there shall be no temporary living quarters constructed on any tract.
5. No commercial enterprises shall be conducted on above described lands nor any tool, implements and equipment incident thereto may be kept thereon.
6. Pets kept on these premises shall be confined to the premises.
7. Tract owner, their families, guests or friends shall do no hunting in Cedar Hills.
8. The foregoing restrictions are to run with the land and shall be binding on all parties and all persons claiming under them until January 1, 1989, etc.

which time said restrictions shall be automatically extended for successive periods of ten years unless changed by vote of a majority of the owners of the building sites covered by these restrictions in whole or in part.

9. Invalidation of any one of the foregoing restrictions by judgment or court order shall in no way affect any other restrictions which shall remain in full force and effect.

10. The right to enforce the provisions by injunction, together with the right to cause the removal, by due process of law, of any structure, or any part thereof erected, or maintained in violation hereof, is hereby dedicated to the public and reserved to the several owners of the several lots in this subdivision and to their heirs and assigns.
