

Clarke's Brookside Gardens, an Addition to the city of Indianapolis and a subdivision that part of the W $\frac{1}{2}$ of the SE $\frac{1}{4}$ of the NW $\frac{1}{4}$ of Sec. 33 T.16 N.R. 4 E., Marion County, Indiana, described as follows; Beginning at the S.W. corner of the SE $\frac{1}{4}$ of the NW $\frac{1}{4}$ of section 33 T.16 N.R. 4 E. and running thence east 667.5 feet along the south line of the NW $\frac{1}{4}$ of said Sec. 33; Thence North 71.78 feet along the east line of the W $\frac{1}{2}$ of the SE $\frac{1}{4}$ of the NW $\frac{1}{4}$ of said section 33; Thence West 671.5 feet on a line parallel to the south line of the NW $\frac{1}{4}$ of said section 33; Thence South 764.78 feet along the West line of the SE $\frac{1}{4}$ of the NW $\frac{1}{4}$ of said section 33, to the place of beginning.

This subdivision consists of sixty six lots numbered from forty three to one hundred and eight including with the number and size of lots and width of streets and alleys marked on the annexed plat in feet and decimals. The streets and alleys are hereby dedicated to the public use.

This subdivision shall be known and designated as Clarke's Brookside Gardens.
