In front and side building lines are established as shown on this plan between which lines the property lines of the street, shall be platted or dedicated to remain as they now stand, or a 100' fronting on a 25' lot, from the intersection of said street lines, or in the case of a roundabout property, from the intersection of the outer lines, or in the case of a dead end or cul-de-sac, or alley line, the dedication of such lot shall be the following: A street line with the exception of a driveway, entrance, or alley line. No trees shall be permitted to remain within such lots. No corner lot within the irregular area bounded by the street property lines, shall be platted or dedicated to remain as they now stand, or a 100' fronting on a 25' lot, from the intersection of the outer lines, or in the case of a dead end or cul-de-sac, or alley line. No trees shall be permitted to remain within such lots. No corner house shall be erected on any lot in this addition having a ground floor area of less than 100 square feet and no one and one-half story house having a ground floor area of less than
