NGW, THEREFORE, be it resolved by the Board of Directors of Country Estates Condominium Owners' Association that the following amendments be made a part of the Code of By-Laws of the Association as recorded as Instrument No. 72-39731.

ARTICLE VI "ADMINISTRATION"
SECTION 6 "RULES AND REGULATIONS: MANAGEMENT

The above Paragraph (a) is hereby deleted from the Code of By-Laws of the Association.

ARTICLE II "ASSOCIATION MEMBERS"
SECTION 3 "ANNUAL MEETINGS"
Section 3 is hereby amended to read:

The annual meetings of the members shall be held on the first Tuesday in April of each year or at such other date during the month of April as the Board of Directors may direct.

IN ADDITION, the following amendments were made to the Code of By-Laws of the Association at an earlier date, but in a search of the records have never been recorded. Under the direction of the Board of Directors the undersigned hereby records these amendments to the Code of By-Laws as follows:

#### ARTICLE III. SECTION 1

As prescribed under the Code of By-Laws of Country Estates Condominium Owners' Association. Horizontal Property Regime, Article III. Section 1, of said By-Laws relating to the number of Board members is hereby amended to read "five (5) Owners".

ARTICLE VII, SECTION 1

Article VII, Section 1, of the Code of By-Laws has been amended to include the following:

"If in the discretion of the Board of Directors it becomes necessary to alter or amend the annual budget—estimated by it for the current year, "it shall have the authority to make such alterations or amendments as it deems proper without prior notice to the members of the Association."

### AMENDMENTS TO THE DECLARATION OF SÜBJI CONDOMINIUM OWNERSHIP FOR COUNTRY ESTATES HORIZONTAL PROPERTY REGIME

These are Amendments to the Declaration of Condominium Ownership and of Easements, Restrictions and Covenants For Country Estates Horizontal Property Regime in Indianapolis, Marion County, Indiana.

#### WITNESSETH:

WHEREAS, the Country Estates condominium community located in Marion County was established by a certain "Declaration of Condominium Ownership and of Easements, Restrictions and Covenants For Country Estates Horizontal Property Regime" (hereafter, "Declaration") which was recorded in 1972, as **Instrument No. 72-39731** in the Office of the Recorder of Marion County, Indiana; and

WHEREAS, said Declaration was amended by an Amendment which was recorded on August 5, 1991, as **Instrument No. 91-79237** in the Office of the Recorder of Marion County, Indiana; and

WHEREAS, Country Estates consists of seventy-six (76) condominium units and Common Areas applicable thereto; and

WHEREAS, defined terms used herein, and not otherwise defined, shall have the meanings ascribed to them in the Declaration; and

WHEREAS, Article X, Section 10.03 of the Declaration states that it may be amended by an instrument signed by (1) the Board of Directors and (2) the Owners having at least three-fourths (3/4) of the total ownership; together with an affidavit by an officer of the Board certifying that a copy of the amendment has been mailed by certified mail to all mortgagees having bona fide liens of record; and

WHEREAS, the Board of Directors of Country Estates Condominium Owners' Association, Inc. recommended that the Owners approve the following amendments to the Declaration; and

WHEREAS, the undersigned Owners, having at least three-fourths (3/4) of the total ownership within Country Estates, desire to amend the Declaration pursuant to the terms and conditions set forth below.

NOW, THEREFORE, the undersigned Owners hereby amend the Declaration. The restrictions contained herein shall run with the land and shall be binding upon the present and future Owners and upon the parties having or acquiring any right, title or interest, legal or equitable, in and to the Country Estates Horizontal Property Regime.

#### 1. There shall be a new Article XIII added to the Declaration as follows:

### Article XIII Leasing of Dwellings and Maximum Number of Dwellings Owned

13.01. Limits on the Number of Leased Dwellings ("Rental Cap"). In order to insure that the residents within Country Estates share the same proprietary interest in and respect of the Condominium Apartments and the Common Areas, no more than ten (10) of the seventy-six (76) Condominium Apartments, which is about thirteen percent (13%), may be leased or rented to non-owner occupants at any given time, except as may be otherwise provided in this Article XIII. If at any time such percentage of Condominium Apartments are leased or rented, an Owner who wants to rent or lease his or her Condominium Apartment which is not already rented shall be placed upon a waiting list by the Board of Directors. When an existing tenant moves out, the Owner of that Condominium Apartment shall immediately notify the Board of Directors or Managing Agent of such fact and that Condominium Apartment cannot be re-rented until all prior Owners on the waiting list, if any, have had a chance to rent their Condominium Apartments. Prior to the execution of any lease, and in addition to the requirements set forth below, the Owner must notify the Board of Directors or the Managing Agent as to that Owner's intent to lease his or her Condominium Apartment. After receiving such notice, the Board of Directors or the Managing Agent shall advise the Owner if Condominium Apartments may be leased or whether the maximum number of Condominium Apartments within Country Estates is currently being leased. If the maximum number of Condominium Apartments is being leased, the Board of Directors or the Managing Agent shall also notify the Owner of that Owner's position on the waiting list.

Notwithstanding the foregoing, the "rental cap" described above shall not apply to any Condominium Apartment of an Owner in Country Estates who, as of September 1, 2000, is renting or leasing said Condominium Apartment and provides written proof thereof to the Association's Managing Agent by that date. Such proof shall include a copy of each executed lease by such Owner which identifies the tenant (but which may have the rental amount deleted). The Owners of record of such currently-rented Condominium Apartments shall not be subject to the provisions of this Section 13.01, but shall be subject to the remaining provisions of this Article XIII. However, when the legal owners of record of any of the above-described Condominium Apartments sell, transfer or convey such Condominium Apartment(s) to another Owner after September 1, 2000, such Condominium Apartment(s) shall immediately become subject to this Section 13.01.

- 13.02. <u>Hardship Exceptions and Waiver</u>. Notwithstanding Section 13.01 above, if an Owner wishes to rent or lease his or her Condominium Apartment, but the maximum number of ten (10) Condominium Apartments is currently being leased, the Owner may request the Board of Directors to waive the "rental cap" and approve a proposed lease if the Owner establishes to the Board's satisfaction that the "rental cap" will cause undue hardship. If a majority of the entire Board of Directors approves in writing of the Owner's request, the Board of Directors shall permit the Owner to rent or lease said Condominium Apartment, but only if the Owner satisfies all other requirements of this Article XIII. Such decision shall be at the sole discretion of the Board. Examples of an undue hardship include:
  - (1) death, dissolution or liquidation of an Owner;
  - (2) divorce or marriage of an Owner;
  - (3) necessary relocation of the residence of an Owner to a point outside of a fifty (50) mile radius of the perimeter of Country Estates due to a change of employment or retirement of at least one (1) of such Owners;
  - (4) necessary relocation of the residence of an Owner due to mental or physical infirmity or disability of at least one (1) of such Owners;
  - (5) other similar circumstances.
- 13.03. General Lease Conditions. All leases, including renewals, shall be in writing, and no lease shall be entered into for a term of less than one (1) year without the prior written approval of the Board of Directors. No portion of any Condominium Apartment other than the entire Condominium Apartment shall be leased for any period. No subleasing shall be permitted. All leases shall be made expressly subject and subordinate in all respects to the terms of the Declaration, By-Laws, Articles of Incorporation, and any rules and regulations promulgated by the Board of Directors, as amended, to the same extent as if the tenant were an Owner and a member of the Association; and shall provide for direct action by the Association and/or any Owner against the tenant with or without joinder of the Owner of such Condominium Apartment. If such provision is not in the lease, it will be deemed to be in such lease. The Owner shall supply copies of such legal documents to the tenants prior to the effective date of the lease. In addition, the Board of Directors shall have the power to promulgate such additional rules and regulations as, in its discretion, may be necessary or appropriate concerning leasing. All Owners who do not reside in the home shall provide the Board of Directors with the name of the tenant(s) and any other residents living in the home.
- 13.04. One Year Waiting Period. In addition to all other provisions of this Article XIII, for a period of at least one (1) year after an Owner's acquisition of a Condominium Apartment, said Owner cannot lease such Condominium Apartment. After such time, said Condominium Apartment will be eligible to be leased if all other conditions of this Article XIII are satisfied and

provided further that the Owner is not delinquent in the payment of any assessments or other charges to the Association. Notwithstanding this Section 13.04, if an Owner wishes to lease a Condominium Apartment prior to the end of the one year waiting period, the Owner may apply to the Board of Directors for a waiver. The Board may, in writing, approve an earlier lease if the Owner establishes to the Board's satisfaction that the waiting period will cause undue hardship in the manner as defined in Section 13.02 above.

- 13.05. Owner is Still Liable. No lease shall provide, or be interpreted or construed to provide, for a release of the Owner from his or her responsibility to the Association and the other Owners for compliance with the provisions of this Declaration, the Articles of Incorporation, the By-Laws, and any rules and regulations promulgated by the Board of Directors, or from the Owner's liability to the Association for payments of assessments or any other charges.
- 13.06. <u>Association's Copy of Lease.</u> A copy of each executed lease by an Owner which identifies the tenant (but which may have the rental amount deleted) shall be provided to the Managing Agent by the Owner within thirty (30) days after execution.
- 13.07. <u>Violations.</u> Any lease or attempted lease of a Condominium Apartment in violation of the provisions of this Article XIII shall be voidable at the election of the Association's Board of Directors or any other Country Estates Owner, except that neither party to such lease may assert this provision of this Article XIII to avoid its obligations thereunder. In the event of a violation, the Board of Directors, on behalf of the Association, or any Country Estates Owner, shall have the right to exercise any and all available remedies at law or equity.
- 13.08. <u>Maximum Number of Condominium Apartments Owned by a Single Owner</u>. In order to encourage Country Estates being and remaining a community where the Owners reside on the property:
  - (a) No Owner may own more than two (2) Condominium Apartments within Country Estates at any time. This restriction shall not apply to any Owner who owns more than two (2) Condominium Apartments which were purchased or with respect to which there was a binding purchase agreement prior to the recording of this restriction.
  - (b) If any Owner is the Owner of more than one (1) Condominium Apartment, such Owner or the majority of the principals of such Owner shall and must reside in Country Estates in at least one (1) of such Condominium Apartments, unless otherwise approved in writing by the Board of Directors upon a showing by such Owner, satisfactory to the Board of Directors, of an undue hardship as defined in Section 13.02 above.

As defined in Article I, Section 1.07 of this Declaration, "Owner" means the record owner, whether one or more persons, of a fee simple title to any Condominium Apartment, including contract sellers. As used in this Section 13.08 above, "Owner" also means those persons or entities who comprise less than all persons or entities who own in any form or manner

the fee simple title or any part thereof to any Condominium Apartment and those persons or entities who have any interest in any form or manner in the fee simple title or any part thereof to any Condominium Apartment. As an example, if any person or entity owns or has any interest in the ownership of two (2) Condominium Apartments, whether in his, her or its name only, as joint tenants, as life tenant or by or through any corporation, partnership, trust, limited liability company, or any other entity, that person cannot own a third Condominium Apartment, whether in his, her or its name only, as joint tenants, as life tenant or by or through a corporation, partnership, trust, limited liability company, or any other entity.

Any purchase agreement, conveyance or lease or rental agreement executed subsequent to the recording of this restriction which violates any provision of this Section 13.08 shall be voidable at the election of the Association's Board of Directors or any Country Estates Owner, except that neither party to such agreement, conveyance or lease may assert this provision of this Article XIII to avoid its obligations thereunder. In the event of a violation, the Board of Directors, on behalf of the Association, or any Country Estates Owner, shall have the right to exercise any and all available remedies at law or equity.

13.09. <u>Institutional Mortgagees</u>. The provisions set forth in this Article XIII shall not apply to any institutional mortgagee of any Condominium Apartment which comes into possession of the Condominium Apartment by reason of any remedies provided by law or in equity or in such mortgage or as a result of a foreclosure sale or other judicial sale or as a result of any proceeding, arrangement, or deed in lieu of foreclosure.

### 2. Article X, Section 10.03 of the Declaration is hereby deleted in its entirety and replaced with the following:

- 10.03. <u>Amendments to Declaration</u>. The provisions of this Declaration may be changed, modified or rescinded in the following manner:
  - (a) <u>Notice</u>. Notice of the subject matter of any proposed amendment shall be included in the notice of the Special Meeting of the Association at which the proposed amendment is to be considered.
  - (b) <u>Resolution</u>. A resolution to adopt a proposed amendment may be proposed by the Board of Directors or Owners having in the aggregate at least a majority of the votes of all Owners.
  - (c) <u>Meeting</u>. The resolution concerning a proposed amendment must be adopted by the designated vote at a meeting duly called and held in accordance with the provisions of the By-Laws.
  - (d) Adoption. Any proposed amendment to this Declaration must be approved by a vote of the Owners of at least two-thirds (2/3) of the total ownership within Country

Estates (either in person or by proxy) at a Special Meeting of the Association duly called for such purpose. The instrument of amendment must be signed by the President and Secretary of the Association and shall be effective when recorded with the Marion County Recorder.

(e) Restrictions on Amendments. No provision in this Declaration may be changed, modified or rescinded so as to conflict with the provisions of the Act. No amendment to this Declaration shall be adopted which changes the percentage interest with respect to any Condominium Apartment without the approval of all Owners.

# THIRD AMENDMENT TO THE DECLARATION OF CONDOMINIUM OWNERSHIP FOR COUNTRY ESTATES HORIZONTAL PROPERTY REGIME

This Third Amendment to the Declaration of Condominium Ownership and of Easements, Restrictions and Covenants For Country Estates Horizontal Property Regime in Indianapolis, Marion County, Indiana.

#### WITNESSETH:

WHEREAS, the Country Estates condominium community located in Marion County, Indiana was established by a certain "Declaration of Condominium Ownership and of Easements, Restrictions and Covenants For Country Estates Horizontal Property Regime" (hereafter, "Declaration") which was recorded in 1972, as Instrument No. 72-39731 in the Office of the Recorder of Marion County, Indiana and

WHEREAS, said Declaration was amended by an Amendment, recorded on August 5, 1991, as Instrument No. 91-79237 in the Office of the Recorder of Marion County, Indiana; and

WHEREAS, said Declaration was further amended by an Amendment, recorded on August 2, 2001 as Instrument No. 2001-0135103 in the Office of the Recorder of Marion County, Indiana; and,

WHEREAS, Country Estates consists of seventy-six (76) condominium units and Common Areas applicable thereto; and

WHEREAS, Article X, Section 10.03 of the Declaration states that it may be amended by a resolution proposed by the Board of Directors and approved by a vote of the Owners having at least two-thirds (2/3) of the total ownership; and

WHEREAS, the Board of Directors of Country Estates Condominium Owners' Association, Inc. has passed a resolution recommending that the Owners approve the following amendments to the Declaration; and

WHEREAS, the Owners, having at least two-thirds (2/3) of the total ownership within Country Estates, have voted to approve the amendments to the Declaration pursuant to the terms and conditions set forth below.

NOW, THEREFORE, the Owners hereby amend the Declaration. The restrictions contained herein shall run with the land and shall be binding upon the present and future Owners and upon the parties having or acquiring any right, title or interest, legal or equitable, in and to the Country Estates Horizontal Property Regime.



1. Article XIII, Section 13.01 of the Declaration is amended to read as follows:

13.01. Limits on the Number of Leased Dwellings ("Rental Cap"). In order to insure that the residents within Country Estates share the same proprietary interest in and respect of the Condominium Apartments and the Common Areas, no more than four (4) of the seventy-six (76) Condominium Apartments, which is about five percent (5%), may be leased or rented to non-owner occupants at any given time, except as may be otherwise provided in this Article XIII. If at any time such percentage of Condominium Apartments are leased or rented, an Owner who wants to rent or lease his or her Condominium Apartment which is not already rented shall be placed upon a waiting list by the Board of Directors. When an existing tenant moves out, the Owner of that Condominium Apartment shall immediately notify the Board of Directors or Managing Agent of such fact and that Condominium Apartment cannot be re-rented until all prior Owners on the waiting list, if any, have had a chance to rent their Condominium Apartments. Prior to the execution of any lease, and in addition to the requirements set forth below, the Owner must notify the Board of Directors or the Managing Agent as to that Owner's intent to lease his or her Condominium Apartment. After receiving such notice, the Board of Directors or the Managing Agent shall advise the Owner if Condominium Apartments may be leased or whether the maximum number of Condominium Apartments within Country Estates is currently being leased. If the maximum number of Condominium Apartments is being leased, the Board of Directors or the Managing Agent shall also notify the Owner of that Owner's position on the waiting list.

Notwithstanding the foregoing, the "rental cap" described above shall not apply to any Condominium Apartment of an Owner in Country Estates who, as of September 1, 2000, is renting or leasing said Condominium Apartment and provides written proof thereof to the Association's Managing Agent by that date. Such proof shall include a copy of each executed lease by such Owner, which identifies the tenant (but which may have the rental amount deleted). The Owners of record of such currently-rented Condominium Apartments shall not be subject to the provisions of this Section 13.01, but shall be subject to the remaining provisions of this Article XIII. However, when the legal owners of record of any of the above-described Condominium Apartments sell, transfer or convey such Condominium Apartment(s) to another Owner after September 1, 2000, such Condominium Apartment(s) shall immediately become subject to this Section 13.01.

In addition, the provisions of this Section 13.01 shall not apply to any Condominium Apartment of an Owner in Country Estates, who, as of December 31, 2006, is renting or leasing said Condominium Apartment in full compliance with the provisions of Article XIII. The Owners of record of such currently-rented Condominium Apartments shall continue to be subject to the remaining provisions of this Article XIII. When the Owner of record of any such Condominium Apartment sells, transfers or conveys such Condominium Apartment to another Owner after December 31, 2006, such Condominium Apartment shall immediately become subject to this Section 13.01.

- 2. Article XIII, Section 13.02 of the Declaration is amended to read as follows:
- 13.02. <u>Hardship Exceptions and Waiver.</u> Notwithstanding Section 13.01 above, if an Owner wishes to rent or lease his or her Condominium Apartment, but the maximum number of four (4) Condominium Apartments is currently being leased, the Owner may request the Board of Directors to waive the "rental cap" and approve a proposed lease, if the Owner establishes to the Board's satisfaction that the "rental cap" will cause undue hardship. If a majority of the entire Board of Directors approves in writing of the Owner's request, the Board of Directors shall permit the Owner to rent or lease said Condominium Apartment, but only if the Owner satisfies all other requirements of this Article XIII. Such decision shall be at the sole discretion of the Board. Examples of an undue hardship include:
  - death, dissolution or liquidation of an Owner;
  - (2) divorce or marriage of an Owner;
  - (3) necessary relocation of the residence of an Owner to a point outside of a fifty (50) mile radius of the perimeter of Country Estates due to a change of employment or retirement of at least one (1) of such Owners;
  - (4) necessary relocation of the residence of an Owner due to mental or physical infirmity or disability of at least one (1) of such Owners;
  - (5) other similar circumstances.
