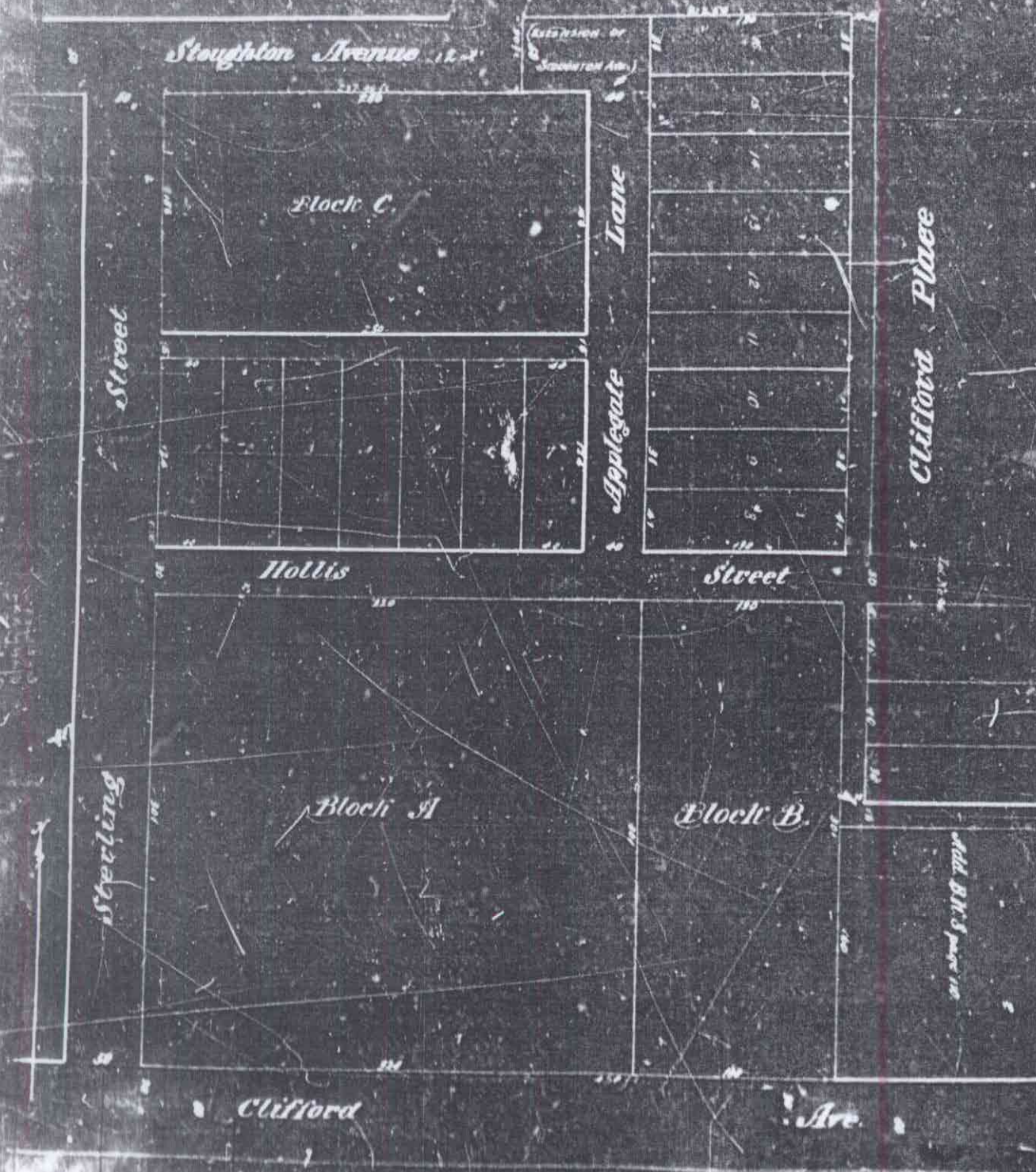


Plat of the Half-Acre Block

That of Henry H. Hanna and Jesse Fletcher, Trustees, Subdividers of part of Section Thirty one (31) in Township Septen (7) North of Range Four & East in Marion County, and State of Indiana, more particularly described as follows, to wit:

Beginning at the intersection of the North line of Clifford Avenue and the East line of Sterling Street, as now laid out and platted, thence East along North line of Clifford Avenue four hundred and fifty (450) feet to a point, thence North, parallel with Sterling Street, six hundred and seventy six (676) feet to a point, thence West, parallel with Clifford Avenue, two hundred and twelve and fifty four hundredths (212 ⁵⁴/₁₀₀) feet, to a point, thence South, parallel with the last described north and south line fifty (50) feet to a point at the eastern extremity as heretofore laid out, of the South line of Stoughton Avenue, thence West along the said South line of Stoughton Avenue, two hundred and seven and forty six hundredths (207 ⁴⁶/₁₀₀) feet, to the intersection of said last line with the East line of Sterling Street, thence South along said East line of Sterling Street six hundred and twenty six (626) feet to the place of beginning. Also, Lot numbered Ninety six (96), in Clifford Place Addition to the City of Indianapolis, in said County and State.

The above described ground is platted into three Blocks, described as Blocks "A", "B" and "C" respectively, and into sixteen (16) Lots numbered from one (1) to sixteen (16) respectively, as is fully shown on the plat, and the said subdivision is to be known by the name of Fletcher Homestead Addition, the same being an Addition to the City of Indianapolis. The measurements are given in feet and decimals of a foot, and the streets and alleys platted are dedicated to the use of the public.

In Witness Whereof the said Henry H. Hanna and Jesse Fletcher, under the Last Will and Testament of Elizabeth B. Fletcher deceased in pursuance of the power given them by said will have hereunto set their hands and seals this 7th day of June A. D. 1890.
