Plat of Henry H. Hanna and Jesse Fletcher, Trustees Subdividers,
part of Section Thirty-one (31) in Township Fifteen (15) North of Range Four (4)
in Marion County, and State of Indiana, more particularly described as
follows, to wit:

Beginning at the intersection of the north line of Clifford Avenue and
the East line of Sterling Street, as now laid out and platted, thence east along
north line of Clifford Avenue four hundred and fifty (450) feet to a point, thence
north, parallel with Sterling Street, six hundred and seventy-six (676) feet to a
thence west, parallel with Clifford Avenue, two hundred and twelve and
fifty-four hundredths (212 54) feet, to a point, thence south, parallel with
last described north and south line, fifty (50) feet to a point at the eastern
extremity as heretofore laid out, of the south line of Stoughton Avenue, then
west along the said south line of Stoughton Avenue, two hundred and
seven and forty six hundredths (207 46) feet, to the intersection of said last
line with the East line of Sterling Street, thence south along said last line
of Sterling Street six hundred and twenty-six (626) feet to the place of beginning.
Also, Lot numbered Ninety-six (96), in Clifford Place Addition to the City
of Indianapolis, in said County and State.

The above described ground is platted into Three (3) Blocks, described as
Blocks "A", "B" and "C" respectively, and into Sixteen $\frac{1}{16}$ Lots numbered from
one (1) to sixteen (16), respectively, as is fully shown on the plat, and the said
Subdivision is to be known by the name of Fletcher's Homestead Addition
the same being an addition to the City of Indianapolis. The measurements
are given in feet and decimals of a foot, and the streets and alleys platted
are dedicated to the use of the public.
