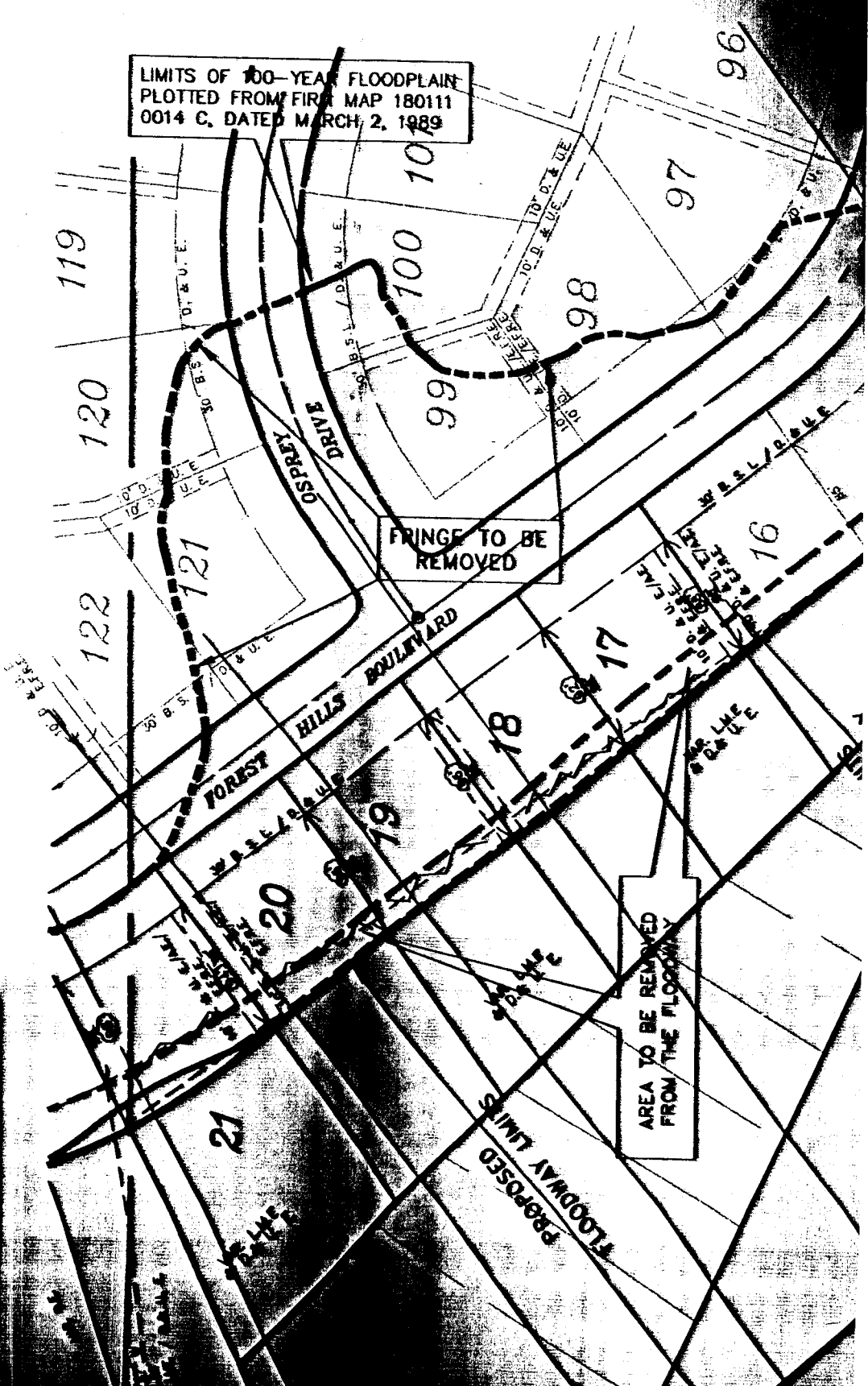

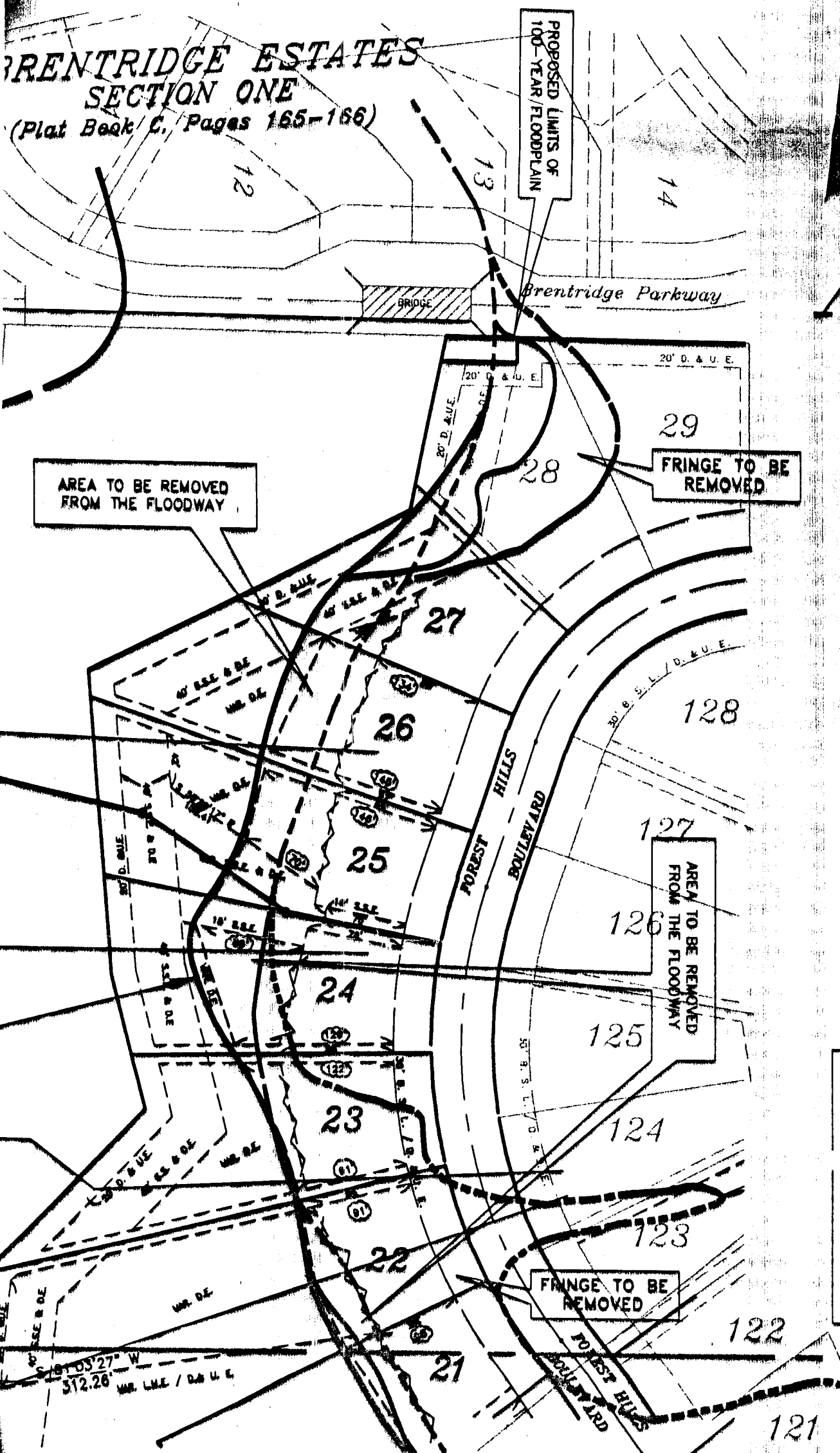

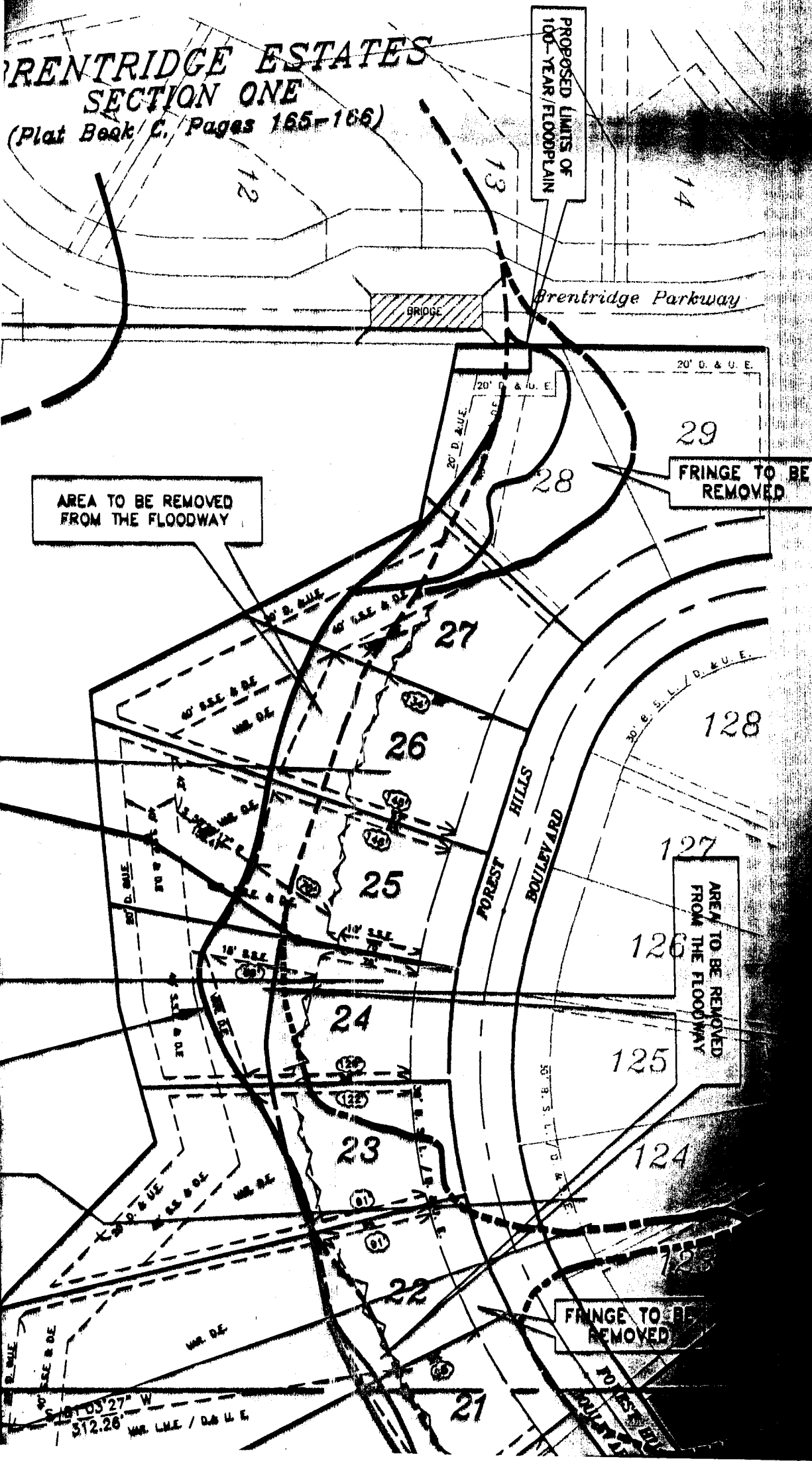
LIMITS OF 100-YEAR FLOODPLAIN
