# The Justus C. Adams South East Addition

## The Justus C. Adams South East Addition

An addition to the City of Indianapolis <sup>Ind</sup> being a subdivision of part of the south west quarter and part of the south east quarter of Section Eighteen (18) Township fifteen (15) North Range four (4) East, in Marion County, State of Indiana, described as follows: Beginning at the south east corner of said south west quarter <sup>and</sup> running west with the south line thereof nine hundred forty eight <sup>and</sup> one tenth (948.1) feet thence north four hundred eighteen <sup>and</sup> eight tenths (418.8) feet to a point in the center line of the trunk sewer projected east, which is nine hundred forty five <sup>and</sup> eight tenths (945.8) feet west of the east line of said south west quarter thence west with the center line of Lawrence Avenue projected east two hundred eighty <sup>and</sup> two tenths (280.2) feet, to the east line of the south half of lot four (4) in O'Neal <sup>and</sup> Adams subdivision projected south, thence south with this projected line <sup>and</sup> the east line of the west half of said lot, four hundred twenty two <sup>and</sup> nine tenths (422.9) feet, to the north line of the O'Neal <sup>and</sup> Adams subdivision thence east in a line with the north line of said <sup>and</sup> Adams subdivision projected east eleven hundred fifty four <sup>and</sup> one half (1154.5) feet, to the east line of said south west quarter thence north with the west line of said south east quarter four hundred ninety three <sup>and</sup> one half (493.5) feet, thence east one hundred <sup>and</sup> fifty five (165) feet thence south parallel to west line of said south east quarter thirteen hundred thirty four <sup>and</sup> twenty five hundredths (1334.25) feet, to the south line of said quarter Section thence west one hundred <sup>and</sup> fifty five (165) feet to the beginning - Containing twenty five <sup>and</sup> fifteen hundredths (25.15) Acres, of which (5.700) Acres are in the south east quarter <sup>and</sup> twenty <sup>and</sup> ten hundredths (25.1) Acres in the south west quarter of said Section.

This subdivision consists of one hundred <sup>and</sup> thirty four (134) lots, with streets <sup>and</sup> alleys, with size <sup>and</sup> numbers of lots <sup>and</sup> width of streets <sup>and</sup> alleys marked on this plat. Distances given in feet <sup>and</sup> decimals.

All streets <sup>and</sup> alleys in this subdivision that have not already been dedicated are now hereby dedicated to public use.

A is the south half mile corner A-D the south line of the south west quarter A-C the south line of the south east quarter <sup>and</sup> A-B the quarter section line between the south east quarter <sup>and</sup> the south west quarter of said Section (18). The tract A-D-E-F was formerly before the vacation lots 7-8-9 <sup>and</sup> 10 in O'Neal <sup>and</sup> Adams subdivision with a little exception which is included in the above lot distances <sup>and</sup> in the <sup>and</sup> Adams subdivision with a portion which is also included in the <sup>and</sup> Adams subdivision. This subdivision to be known <sup>and</sup> designated as The Justus C. Adams South East Addition.

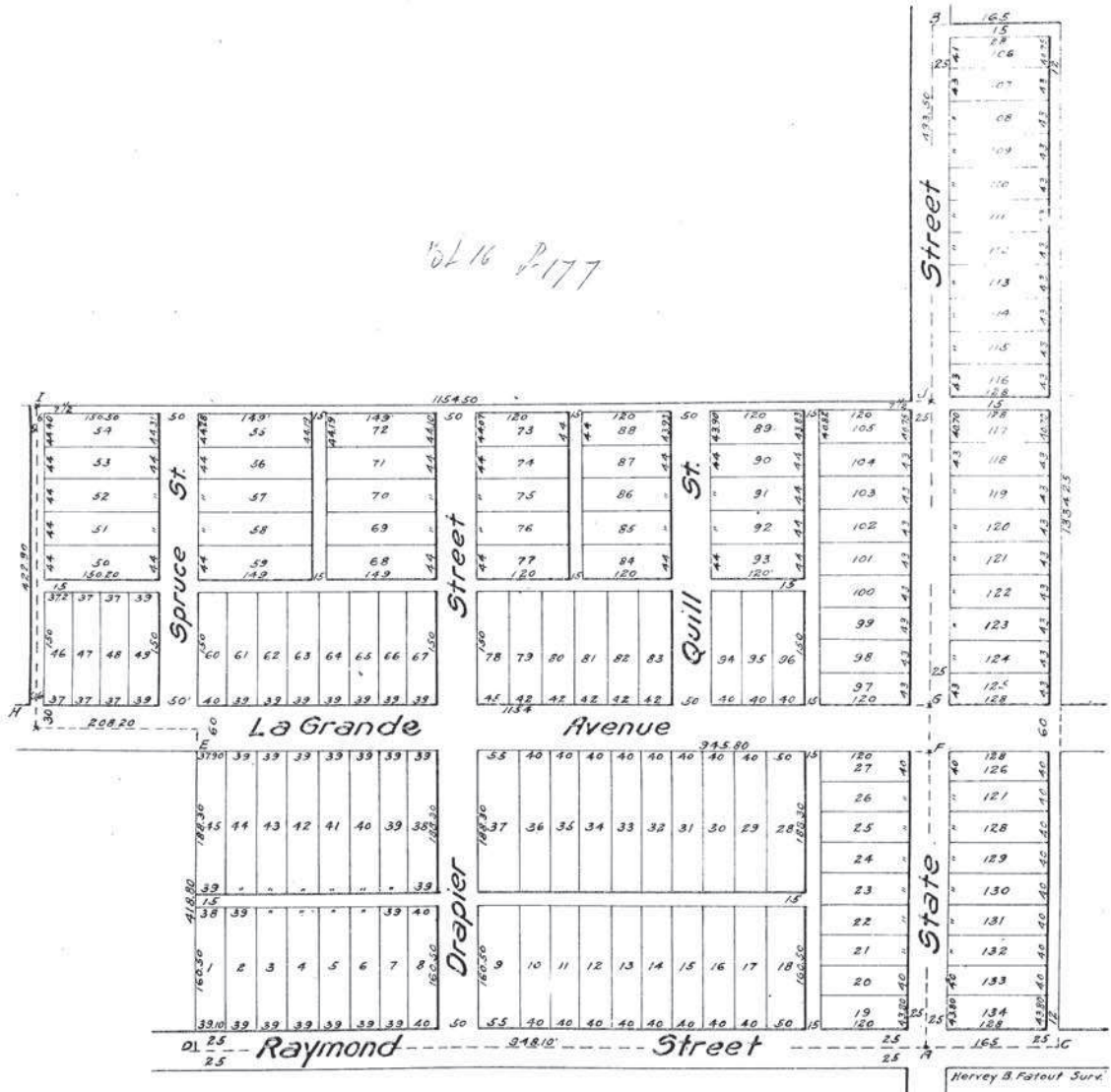
