Being a Resubdivision of the Lots 1 to 25 inclusive in Hartman's Broadway Addition to the City of Indianapolis, as recorded in Plat Book 14, page 54, in the Recorder's Office of Marion County, and a subdivision of a tract of land immediately South of said Hartman's Broadway Addition, all in the SE 1/4 Section 12, Twp 16 N, R. 3, E. The said tract of land containing 10 <sup>5</sup>/<sub>100</sub> Acres is more particularly described as follows: Beginning at a point 937 <sup>7</sup>/<sub>100</sub> feet South of the north line and 392 <sup>5</sup>/<sub>100</sub> feet east of the west line of said 1/4 Section. (thence East parallel to the north line of said 1/4 Section 802 <sup>5</sup>/<sub>100</sub> feet; thence South parallel to the west line of said 1/4 Section 567 <sup>7</sup>/<sub>100</sub> feet; thence West parallel to the north line of said 1/4 Section 802 <sup>5</sup>/<sub>100</sub> feet; thence North parallel to the west line of said 1/4 Section 567 <sup>7</sup>/<sub>100</sub> feet to the place of beginning.
