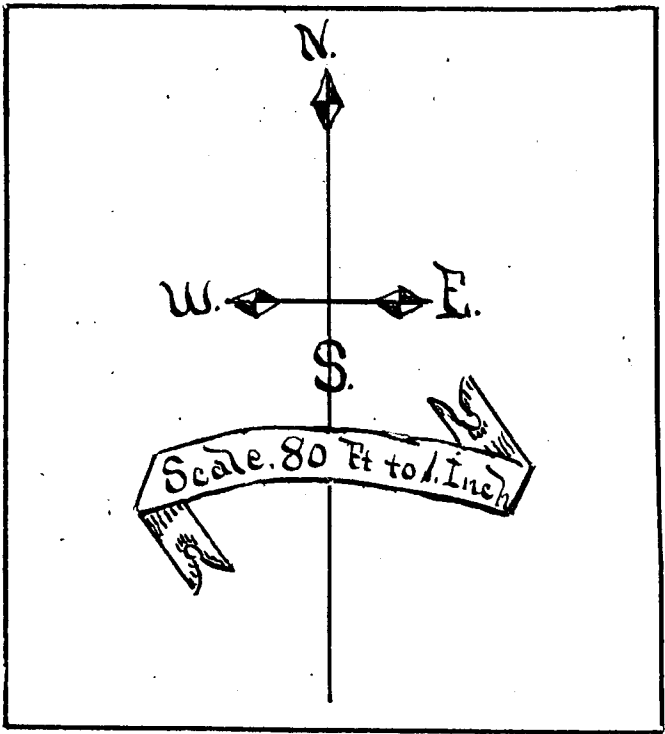


Plat of East Greenwood Indiana.

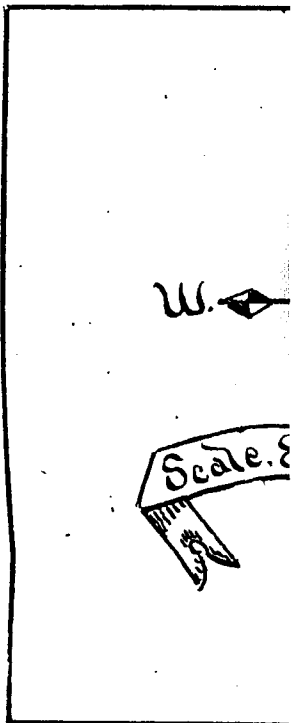
