Robert Hamilton do hereby make an addition to the City of Hamilton Johnson County State of Indiana. 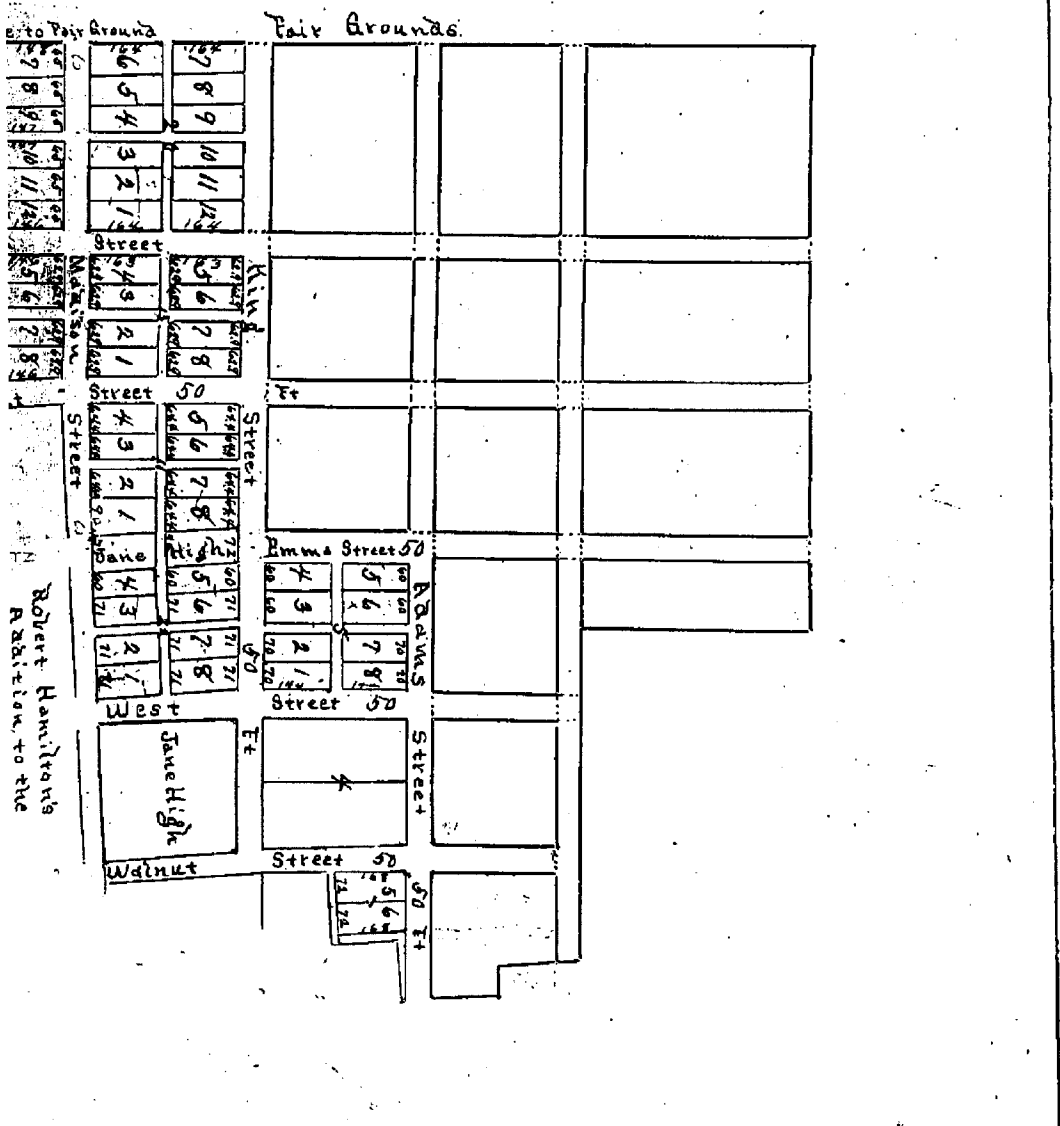

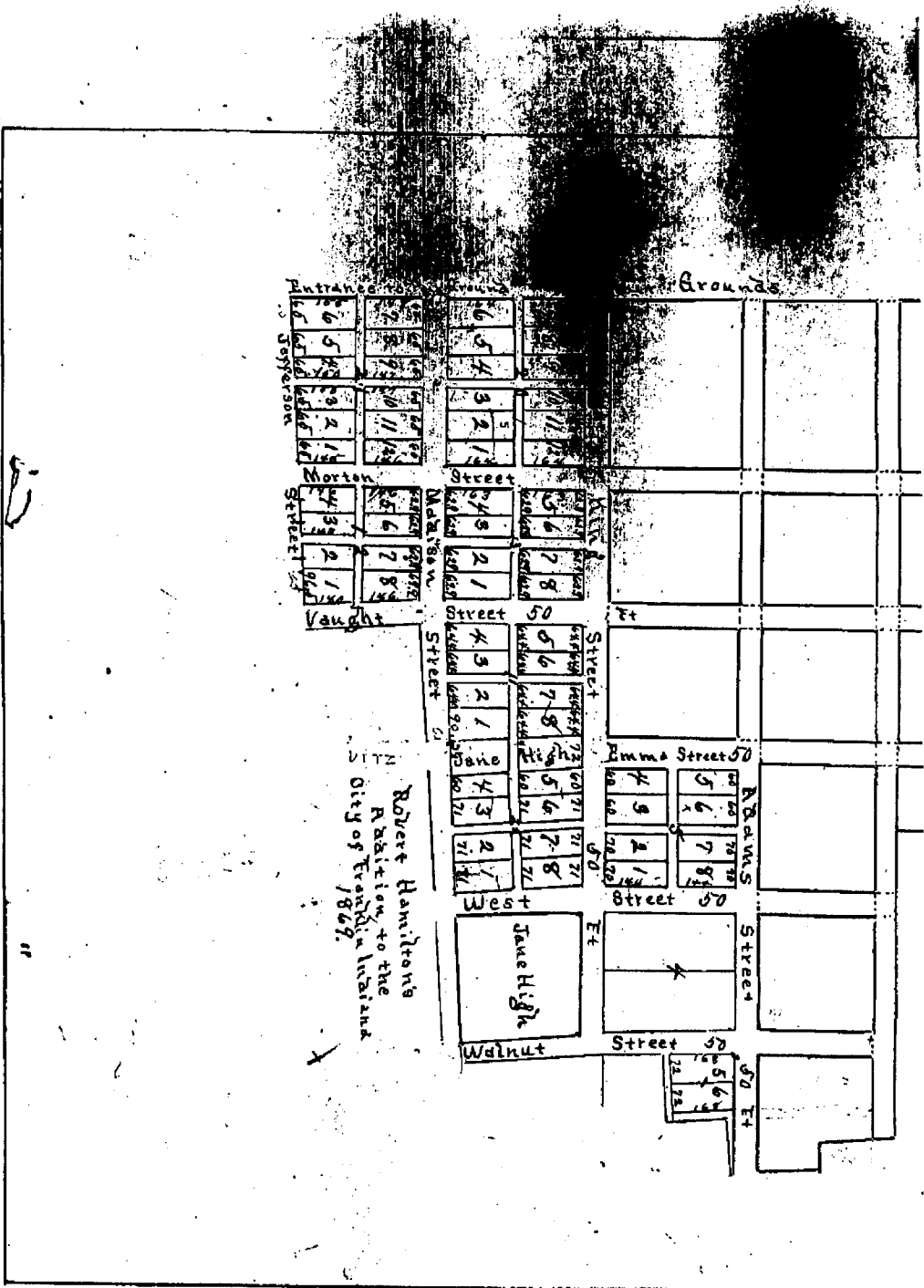
