The streets shown and not heretofore dedicated are hereby dedicated to the public as a right-of-way for public streets.

All numbered lots in this addition shall be dealgrated as residential lots. Only one single family dwelling with accessory building shall be permitted on any lot, and no lot or dwelling shall be used for any purpose other than single family residence. No structure shall exceed two stories in height.

The ground floor area of the main structure, exclusive of one story open porches and garages, whall not he less than 850 square feet for a one story dwelling, nor less than 720 square feet for a dwelling of more than one story.

No building shall be located on any lot nearer to the front lot line or nearer to the side atreet line than the notitions building setback lines shown on the plat. No dwelling shall be located on any lot nearer than 20 feet to the reat lot line. Minimus side yard shall be four feet with an aggregate of ten feet. No accessory building shall be located closer to any front or side lot line than the required minimum; front and side yard distances for the primary dwelling. No accessory building shall be located closer to any rear lot line than five feet, but in no case shall it encreases upon any exercist.

No dwelling shall be erected or placed on any lot having a width of less than fifty feet at the minimum building setbauk line, nor shall any dwelling be erected or placed on any lot having an area of less than 5,000 square feet for a one family dwelling.

The strips of ground marked "Utility and/or Drainage Essements", shown herein, are hereby reserved for the installation and maintenance of public utility poles, wires, conduits for gas, water, electric and telephone utilities, and sanitary and soorm sever, subject to all increase, the proper civil authority and to the specific essement herein reserved. No permanent or other structure shall be exercted or maintained upon said essements and all lot owners shall take their title subject to the rights of the utilities and to the rights of the other owners of lots in this subdivision.

No trailer, test, abook, garage, barn or other temporary structure erected or placed in this subdivision shall be at any time used as a residence, temporarily or permenently, nor shall any other structure of a temporary nature be used as a residence,

No pozicial or offensive trade or activity shall be carried on upon any lot in this subdivision, nor shall anything be done thereon which may be or become a nulsance or annoyance to the neighborhood. No atcoholic beverage or malt or vinous liquor shall be made or sold upon any lot in this subdivision.

No fence, wall, heige or shrub planting which obstructs sight lines at elevations between two and six feet above the ground shall be placed or permitted to remain on any corner but within the triangular area formed by the affect property line and a line connecting points 2b feet from the intersection of said street lines, or in the case of a rounded property corner, from the intersection of the street property lines extended. The same sight line limitations shall apply to any lot within 10 feet from the intersection of a street line with the edge of a driveway pavement or feet from the intersection of a street line with the edge of a driveway pavement or failby line. No trees shall be permitted to remain withis such distance of such intersection, unless the foliage is maintained at sufficient height to prevent obstruction of such sight lines.

No sign of any kind shall be displayed to the public view on any lot except one professional sign of not more than one square foot, one sign of not more than five square feet, advertising the property for sale or rest, or signs used by a bailder to advanting the stronger that construction and splant mentals.
