CONSTRUCTED AND MAINTAINED IN GOOD
 ORDER AND APPROVED IN WRITING BY THE
 PUBLIC HEALTH OFFICER.
 ALL BUILDINGS ERECTED HEREON SHALL
 BE OF A PERMANENT CHARACTER AND SHALL
 BE CONSTRUCTED OF BRICK OR CONCRETE
 OR OTHER MATERIALS OF EQUAL STRENGTH
 AND DURABILITY. ALL BUILDINGS ERECTED
 HEREON SHALL HAVE A EXTERIOR FINISH
 OF PLASTER OR OTHER MATERIALS OF
 EQUAL STRENGTH AND DURABILITY.
 NO BUILDING SHALL BE CONSTRUCTED
 HEREON WITHOUT THE APPROVAL OF THE
 PUBLIC HEALTH OFFICER.
 THE PUBLIC HEALTH OFFICER SHALL
 HAVE THE RIGHT TO INSPECT AND
 INSURE ANY LOT IN THIS ADDITION
 AND TO TAKE SUCH ACTION AS MAY BE
 NECESSARY TO ENFORCE THE PROVISIONS
 OF THIS ADDITION.
 ALL RIGHTS AND RESTRICTIONS BY
 THE CITY OF ELZE IN THE ZONING
 ORDINANCES OR ANY STRUCTURE, OR
 IN ANY DEEDY DEDICATION TO THE
 CITY OF ELZE, SHALL REMAIN AND
 SHALL BE DEEMED TO HAVE BEEN
 INCORPORATED INTO THIS ADDITION
 AND SHALL BE FULLY ENFORCED
 HEREON. ALL THE ABOVE RESTRICTIONS
 AND/OR COVENANTS SHALL RUN WITH THE LAND
 AND SHALL REMAIN IN FULL FORCE AND
 EFFECT UNLESS OTHERWISE SPECIFIED
 HEREON. ALL RIGHTS AND RESTRICTIONS
