

THAT IS FEET TO ANY INTERIOR CORNER OF THE FRONT LOT LINE NEARER TO THE FRONT LOT LINE THAN THE MINIMUM BUILDING SET BACK LINES SHOWN ON THE RECORDED PLAN. NO BUILDING SHALL BE LOCATED NEARER THAN FIVE FEET TO ANY CORNER OF THE FRONT LOT LINE NEARER TO THE FRONT LOT LINE THAN THE MINIMUM BUILDING SET BACK LINES SHOWN ON THE RECORDED PLAN. NO BUILDING SHALL BE LOCATED NEARER THAN FIVE FEET TO ANY CORNER OF THE FRONT LOT LINE NEARER TO THE FRONT LOT LINE THAN THE MINIMUM BUILDING SET BACK LINES SHOWN ON THE RECORDED PLAN. NO BUILDING SHALL BE LOCATED NEARER THAN FIVE FEET TO ANY CORNER OF THE FRONT LOT LINE NEARER TO THE FRONT LOT LINE THAN THE MINIMUM BUILDING SET BACK LINES SHOWN ON THE RECORDED PLAN.

5. LOT AREA AND DIMENSIONS

NO LOT SHALL BE RECONFIGURED, PART, NOW SMALL AND NEARLY AS PLOTTED OR PLACED ON ANY LOT HAVING A WIDTH OF LESS THAN 100 FEET AT THE MINIMUM BUILDING SET-BACK LINE OR AN AREA OF LESS THAN 13,500 SQUARE FEET.

6. EASEMENTS

EASEMENTS FOR INSTALLATION AND MAINTENANCE OF UTILITIES AND DESIGNATED FACILITIES ARE GRANTED AS SHOWN ON THE RECORDED PLAN AND OVER THE NEAR TEN FEET OF EACH LOT.

7. UTILITIES

NO HOLDING OR OPERATING ACTIVITY SHALL BE ENGAGED IN UPON ANY LOT, NOW SMALL, EXCEPT AS PROVIDED BY THE RECORDED PLAN AND OVER THE NEAR TEN FEET OF EACH LOT.

8. TEMPORARY STRUCTURES

NO STRUCTURES OF A TEMPORARY CHARACTER, TENT, SHED, BARN, OR OTHER SUBSTANTIAL BUILDING SHALL BE USED ON ANY LOT AT ANY TIME AS A RESIDENCE EITHER TEMPORARILY OR PERMANENTLY.

9. SIGNS

NO SIGN OR ADVERTISING SHALL BE DISPLAYED TO THE PUBLIC FROM ANY LOT OTHER THAN THE PROFESSIONAL SIGN OF A NOTARY PUBLIC OR A REAL ESTATE BROKER OR SALESMAN OR A SIGN FOR THE PROPERTY DURING THE CONSTRUCTION AND SALES PERIOD.

10. SIGNAGE AND RECORDS DISSENT

NO LOT SHALL BE USED OR MAINTAINED AS A BUSINESS OFFICE OR OFFICE OF A PROFESSIONAL PERSON OR BUSINESS, TRADING, BANKING OR OTHER OFFICE SHALL NOT BE USED EXCEPT IN ACCORDANCE WITH THE PROVISIONS OF THE ZONING ORDINANCE OF SUCH MATERIAL SHALL BE KEPT IN A CLEAN AND SATISFACTORY CONDITION.

11. ELECTIONS TO ZONE

NO ANIMALS, EXCEPT DOGS OR CATS, OR ANY KIND SHALL BE KEPT OR RAISED, EITHER IN A HOUSE OR IN ANY OTHER BUILDING, OR IN ANY OTHER PLACE, EXCEPT THAT THEY ARE NOT KEPT, OWNED OR MAINTAINED FOR ANY COMMERCIAL PURPOSE.

12. SIGNY DISTRICTS

NO FENCE, WALL, HEDGE OR OTHER OBSTACLE WHICH OBSCURES OR CONCEALS THE SIGNATURE OF THE PROPERTY SHALL BE PLACED OR PERMITTED TO REMAIN ON ANY CORNER LOT WITHIN THE DISTRICTS ESTABLISHED BY THE CITY COMMISSIONERS. THE SIGNATURE OF THE PROPERTY SHALL BE KEPT CLEAR OF ANY CORNER LOT WITHIN THE DISTRICTS ESTABLISHED BY THE CITY COMMISSIONERS.

13. DIRT OR MINING OPERATIONS

NO DIRT, MUD, OR OTHER MATERIAL SHALL BE PLACED OR PERMITTED TO REMAIN ON ANY LOT, NOW SMALL, EXCEPT AS PROVIDED BY THE RECORDED PLAN AND OVER THE NEAR TEN FEET OF EACH LOT.

14. SPECIAL ACQUISITIONS

THE CITY COMMISSIONERS SHALL HAVE THE RIGHT TO ACQUIRE ANY LOT, NOW SMALL, EXCEPT AS PROVIDED BY THE RECORDED PLAN AND OVER THE NEAR TEN FEET OF EACH LOT.

15. GENERAL PROVISIONS

THESE PROVISIONS ARE TO BE READ WITH THE LAND AND SHALL BE BINDING ON ALL PARTIES AND ALL PERSONS CLAIMING UNDER THEM FOR A PERIOD OF TWENTY-FIVE YEARS FROM THE DATE THESE PROVISIONS ARE RECORDED.

16. LIABILITY

THE CITY COMMISSIONERS SHALL NOT BE LIABLE FOR ANY DAMAGE TO PERSONS OR PROPERTY CAUSED BY THE OPERATION OF THE PROVISIONS HEREIN.

17. RECORDS

THESE PROVISIONS SHALL BE KEPT ON FILE IN THE OFFICE OF THE CITY COMMISSIONERS AND SHALL BE AVAILABLE TO THE PUBLIC.

18. AMENDMENTS

THESE PROVISIONS MAY BE AMENDED BY THE CITY COMMISSIONERS AT ANY TIME.

19. SEVERABILITY

IF ANY PROVISION OF THESE PROVISIONS IS HELD TO BE UNLAWFUL OR UNENFORCEABLE, THE REMAINDER SHALL REMAIN IN FULL FORCE AND EFFECT.

20. ENTIRE AGREEMENT

THESE PROVISIONS SHALL BE THE ENTIRE AGREEMENT BETWEEN THE PARTIES AND SHALL SUPERSEDE ALL OTHER AGREEMENTS.
